### CAUTION: Beware of Fraudulent Claims and Information

Dear **EBNMP Canada** DNM and Practitioner Members:

**It has come to our attention that EBNMP Canada members have received communications requesting additional funds for membership upgrades and renewals.** If you are an EBNMP Canada member in good standing, renewal fees are not due until January 2007.

Due to the phenomenal growth of your organization the Examining Board of Natural Medicine Practitioners Inc did establish a North American Board (EBNMP-NA) in 2002 to register our USA members along with our Canadian members, but the low numbers of applicants in the US, mainly due to our inability to staff an American registry office, forced the EBNMP to close this board on February 12<sup>th</sup>, 2003. As a result of this closure, the EBNMP Canada was founded on February 13<sup>th</sup>, 2003 and is still currently in existence, providing services to its active members across Canada.

In 2006, a director of the EBNMP, who had knowledge of the dissolved company (EBNMP-NA) decided to resurrect the old company name and portray this entity as the original company. We must stress that this act is unethical and misleading to the general public and should you be contacted by anyone representing this board (EBNMP-NA) offering an upgraded membership, you should guide yourself accordingly. Further to this, all the sanctions, affiliations, and accreditations belong to the EBNMP Canada and it's members as this was the only existing Canadian organization for DNM's and Practitioners at the time the sanctions were awarded. These sanctions and accreditations remain in effect for EBNMP Canada members until they are withdrawn by the organizations which gave the authority.

Your Board of Directors strongly oppose a misuse of trust and security and have cautioned all directors, governors and advisors of EBNMP Canada not to place their personal goals and ambitions ahead of the security and trust of the EBNMP Canada members.

We appreciate your attention to this letter and further advise you that the By-Laws of EBNMP Canada strictly prohibits one director, as a single entity, taking action on behalf of the Board of Directors without the consent of the Board of Directors.
